## Call for nominations for the IDB Prize in Islamic Banking and Finance for 1439H (2018G)

The Islamic Development Bank Group is pleased to invite individuals, universities, academic, financial and Islamic institutions throughout the world to nominate whoever they deem eligible to be awarded the IDB Prize for the year 1439H (2018G) in the field of Islamic Banking and Finance. The Prize which aims to recognize, reward and encourage creative efforts of outstanding merit in the field of Islamic Banking and Finance, consists of a citation carrying the IDB's emblem and a cash award of 30,000 Islamic Dinars (approximately US\$ 45,000).

### *The Conditions Required for the Nomination of Individuals*

1. A Nominee should have made an academic or practical contribution of outstanding merit in the field of Islamic Banking and Finance.
2. Research works, submitted for the Prize, should be published and academically recognized.
3. Services of the Nominee should have an effective impact on the development of Islamic Banking and Finance.
4. The Nominee should not be a Staff Member of IDB Group.
5. Self-nomination and the nomination of deceased researchers are not acceptable.

### *The Conditions Required for the Nomination of Institutions:*

1. The Nominated Institution should have made an academic or practical contribution of outstanding merit in the service of Islamic Banking and Finance.
2. Services of the Nominated Institution should have an effective impact on the development of Islamic Banking and Finance.
3. The Nominated Institution should be recommended by at least one or more eminent scholars in field of Islamic Banking and Finance.
4. The Nominated Institution should not have been awarded the IDB Prize before.
5. Nomination of institutions by its Management is not acceptable.

### *The Requirements for the Nomination:*

1. The nomination form (to be downloaded from IRTI website).
2. The Letter of Nomination (in one of the three languages: Arabic, English or French) should motivate the reasons for the nomination.
3. The detailed Curriculum Vita for the individual/ A detailed prospectuses for the Institution.
4. 5 most relevant research works/publication/services submitted in support of the nomination.
5. A detailed report (with executive summaries) of all the research works/publication/services of the nominee. The detailed report should be carefully elaborated since it is very important for the evaluation.
6. The above documents should be sent by email to [idbprize@isdb.org](mailto:idbprize@isdb.org) before 26 Safar 1439H (15 November 2017).
7. Books/research papers/etc. that cannot be sent by email should be mailed in hard copies to the below mentioned address and delivered to the Preparatory Committee of the IDB Prize before 12 Rabi Al-Awal 1439H (30 November 2017)
8. Any nomination received after the first deadline will not be considered.

### *Prize Awarding:*

The Winner(s) of the award will be honored at a ceremony at the IDB Group Annual Board of Governors meeting. The IDB Group reserves the right to withhold awarding the Prize.

### *Important Dates:*

26 Safar 1439H (15 November 2017): Deadline for receiving nominations.

April 2018: Announcement of the Laureate (s).

Award ceremony during IDBG annual meeting 2018.

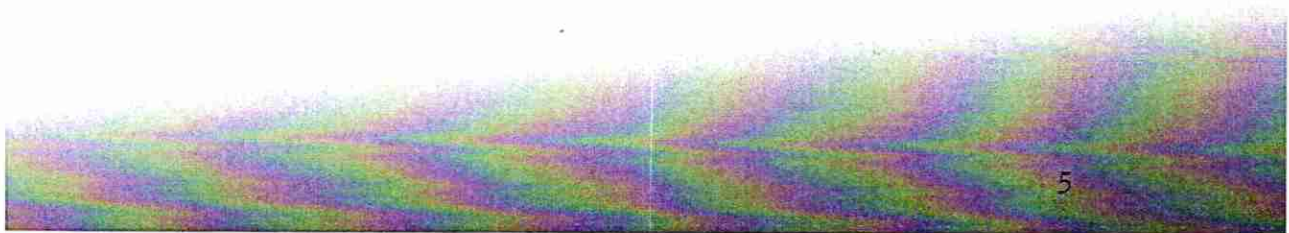
## INTRODUCTION

In 1408H (1988G) the Islamic Development Bank announced in Jeddah the establishment of a new global Prize to be awarded annually: the "IDB Prize in Islamic Economics & Islamic Banking and Finance".

The Islamic Research and Training Institute (IRTI), which is located in the IDB headquarters in Jeddah, Saudi Arabia, became the General Secretariat of the Prize.

This internationally acclaimed Prize has proven to be one of IDB Group's key contributions in recognizing, rewarding and encouraging activities of outstanding merit in promoting excellent work in Islamic economics banking and finance.

## GOALS OF THE PRIZE

The Islamic Development Bank (IDB) established an International Prize since 1408H (1988G) to be awarded on an annual basis alternating between Islamic Economics & Islamic Banking and Finance. The goals of the IDB Prize is to recognize, reward and encourage creative and pioneering efforts of outstanding merit in the field of Islamic Economics & Islamic Banking and Finance.

## THE PRIZE CONSTITUENTS

1. A Citation containing the carrying the Bank's Emblem
2. A Cash Award

## BRANCHES OF THE PRIZE

1. Islamic Economics
2. Islamic Banking and Finance



## CALL FOR NOMINATIONS

The Islamic Development Bank Group invites annually individuals, universities, academics, financial and Islamic institutions from all over the world, to nominate whoever they deem eligible to be awarded the IDB Prize.

## CONDITIONS FOR NOMINATION

1. A Nominee should have made an academic or practical contribution of outstanding merit in the field of Islamic Economics or Islamic Banking and Finance.
2. The services of the Nominee should have an effective impact on Islamic Economics and its development.
3. The Research Works, submitted for the Prize, should not have been awarded any International Prize before.
4. The Research Works, submitted for the Prize, should be published and/or academically recognized.
5. The Nominated Institution should be recommended by at least one or more eminent scholars in the field of Islamic Economics or Islamic Banking and Finance.





## THE FOLLOWING NOMINATIONS ARE NOT ACCEPTED

1. The nomination of non living persons.
2. Self-nomination of institutions or individuals.
3. Staff members of the IDB Group.
4. Nomination of more than one Nominee by the same institution.
5. The nomination of ex-officials of the IDB Group, less than one year's discontinuity from service.

## NOMINATION REQUIREMENTS

The Nominator should make sure that all the requirements for their nominations are fulfilled as listed below.

1. The Nomination Form (found in [irti.org](http://irti.org) website) is dully filled in
2. A Nomination Letter covering the following:
  - The Identification of the Nominee and the specific details of the submitted work (such as research, teaching, training or practice).
  - The impact of the submitted work on Islamic Economics or Islamic Banking and Finance.
  - The details of the Nominee's current activities.
  - Copies of possible media coverage concerning the Nominee and the submitted work.

3. Four (4) copies of each of the Research Work submitted in support of the nomination together with their abstracts.
4. **For Individual Nominees:** Four (4) copies of their Curriculum Vitae that includes the nominee's education, positions held, academic affiliations, a list of key patents and publications, honors granted and awards received.
5. **For Institution Nominee:** Four (4) copies of its prospectus and at least one recommendation from an eminent scholar in the field of Islamic Economics or Islamic Banking/Finance.

## EVALUATION OF NOMINATED WORKS

An independent panel of distinguished scholars and/or practitioners that changes every year, serves as judges in examining and evaluating the submitted nominated works, in order to determine their academic and/or practical value and originality, and how they contribute to the field of Islamic Economics or Islamic Banking and Finance, and their usefulness to the society, especially with reference to the economic development of IDB member countries and to solving problems on an international level from Islamic perspectives. The Prize places great emphasis on enlisting the participation of scholars of the highest caliber to act as members of these committees.

## SELECTION PROCESS

The selection process goes through the following specialized Committees:

1. The Preparatory Committee made up of three members. It receives the nominations, prepares a report to be submitted to the Screening Committee together with the received nominations and preserves all related files.
2. The Screening Committee made up of seven (7) scholars. It evaluates each nomination and short list up to 10 nominations to be submitted to the Selection Committee, giving reasons for their shortlistings.
3. The Selection Committee made up of a panel of seven (7) scholars. It evaluates the report of the Screening Committee and decide by majority on the final selection of the Laureate.

The Winner(s) of the award will be honored at a ceremony at the IDB Group Annual Board of Governors meeting, and will be profiled in the IRTI Journals in Islamic Economics in all the three working languages of the IDB Group (Arabic, English and French) and featured in all IDB Group events and publications.
