CHAPTER ONE Purpose and Basis

Purpose:

Article 1- (1) The purpose of this Regulation is to determine the Principles of Undergraduate Education to be applied to students who transfer vertically to Gebze Technical University based on the Central Vertical Transfer Examination (DGS) conducted by OSYM.

Basis

Article 2- (1) This regulation has been prepared based on Article 9 of the Regulation on the Continuation of Undergraduate Education of Vocational Schools and Open Education Associate Degree Program Graduates, published in the Official Gazette dated 29.07.2011 and numbered 28009 by the Council of Higher Education.

CHAPTER TWO Principles and Operation

Article 3- (1) Students enrolled through vertical transfer are first admitted to the English Exemption Exam. Those who pass the exemption exam are admitted to the undergraduate program. Unsuccessful students, however, are required to attend the English Preparatory Class for one year. After completing the preparatory class, if they succeed in the English Exemption Exam, they can start their undergraduate studies; if they fail, they are given another opportunity to pass the exam after one year. During this period, students cannot attend classes. They can only take the undergraduate English proficiency exams. At the end of this period, if students still cannot succeed, their relationship with the university is terminated. Students who fail in either the first or second year, if they wish, can apply to the Student Selection and Placement Center to be placed in universities where English instruction is not mandatory, in accordance with the twelfth paragraph of Article 7 of the Regulation on the Principles to be Followed in Foreign Language Education and Instruction with Foreign Language in Higher Education Institutions published in the Official Gazette dated 4/12/2008 and numbered 27074.

(2) Students who have the right to start undergraduate education and training are granted exemption based on the evaluation of the relevant Exemption and Equivalency Committees and the decision of the relevant Department Management Boards for courses deemed equivalent to those taken during their associate degree education. Article 5. (1) The GTU Vertical Transfer License implementation directive and its amendments, which entered into force with the decision of the University Senate dated 13.06.2007 and numbered 2007/09, have been repealed by this directive.

Validity

Article 6. (1) This Directive entered into force with the decision of the Gebze Technical University Senate dated 08.09.2011 and numbered 2011/23.

Execution

Article 7. (1) The provisions of this directive shall be executed by the Rector of Gebze Technical University.
