IMPORTANT ISSUE TO BE CONSIDERED:

In this announcement, our university has announced only within the scope of foreign student admission quotas, has not determined a quota for those who have a special situation regarding a specific country, situation and identity form, and all students who will make final registration are subject to the specified tuition fees.

Required Documents for Application

1. Application Form

The application form is found at http://www.gtu.edu.tr during the application period.*

*7th article of 5901 numbered Turkish Nationality Law states that "(1) Those who are born of a legal marriage of a Turkish mother or father in or out of Turkey are Turkish citizens" which international degree applicants had better read before application.

2. A Valid Document of Exam Result (English or Turkish)

The original or notarized copy of the exam result certificate that will be used for application. If the certificate has been issued in a language other than Turkish or English, its notarized translation into Turkish or English is also to be submitted.

NOTE:

Only the exams specified in Gebze Technical University Application, Admission and Registration Directive for International Students (https://www.gtu.edu.tr/fileman/Files/UserFiles/kalite/Yönergeler/YO-0011 Yabanc Uyruklu Orencilerin Bavuru Kabul ve Kayt Yonergesi R4.pdf) are admitted. It is not possible to apply with an exam apart from these ones, otherwise application will be invalid.

3. High School Diploma (Turkish)

A Turkish Embassy/Consulate/Public Notary-approved Turkish copy of the high school diploma.

4. Certificate of Equivalency (Turkish)

A notarized or consularized copy of the "Certificate of Equivalency", which shows that the applicant's high school diploma is equivalent to the diplomas granted by the high schools in Turkey and can either be received from the Ministry of Education of the Republic of Turkey or from the Turkish Embassy in the applicant's country. Non-notarized/non-consularized documents are not accepted.

5. Official Grade Report (Turkish)

A Turkish Embassy/Consulate/Public Notary-approved Turkish copy of the Official Grade Report that has been approved by the applicant's High School Principal, demonstrating the courses and grades receive by the applicant.

6. Official Document Showing Possible Graduation Date (Turkish)

Students whose graduation is delayed due to the **COVID-19 pandemic** will be able to upload Turkish version of official document which is showing approved- possible graduation date and given by high school authorities instead of the documents in Articles 3., 4. and 5.

Students who succeed will be registered conditionally and be able to submit their documents until December 15th 2021.

7. Passport Information (Turkish)

The original page of the applicant's passport showing the identity information of the applicant and its Turkish Embassy/Consulate/Public Notary-approved Turkish copy.

8. Photo

1 passport size (4.5 x 6 cm) biometric photograph of the applicant (taken within the last six months in a way to identify the applicant easily).

9. Bank Receipt (Turkish)

International degree seeking students must submit a bank receipt confirming that applicant has, on their own name, a bank account which covers at least 3.000USD in order to prove their financial capacity of studying in Turkey (EFT or e-banking receipts can only be accepted if confirmed by the bank).

If it is found that the applicants who have been announced as either main or reserve candidates submitted missing, misleading and false statements, or false documents during application, they will not be enrolled. And those who are identified with similar situations after their enrollment has been finalized will be dismissed pursuant to the relevant legal legislation.

*Any circumstances arising due to force majeure will be announced on GTU's website.

Submission of Required Documents

Applicants will upload demanded documents to system which will be open between <u>August 2th -20th 2021</u> on http://www.gtu.edu.tr

The applications which are not submitted on related time interval will not be processed.

Evaluation of Applications

Undergraduate program applications are evaluated by GTU International Student Admissions Committee. The structure of the Committee is determined by the decision of the Senate. The applicants who are found not to meet the application requirements as a result of preliminary evaluation will not be evaluated further.

Announcement of Application Results

Application results are announced on the GTU website. The acceptance letter required for a study visa by the candidates that have been accepted and state that they will finalize their enrollment will be sent to the e-mail address they have specified in their application form. The candidates that do not show up to finalize their enrollment within the informed period lose their rights to enroll.

Enrollment

Student enrollments are carried out by the Directorate of Student Affairs between the dates specified in the yearly Academic Calendar.

Tuition Fees and Financial Assurance Amount

A tuition fee determined by the University Senate, provided that it falls within the minimum and maximum limits designated by the Decree of the Presidency of the Republic of Turkey every year, is received from the students that will be accepted from abroad or from foreign national students. Current fees are indicated in table below.

Those who will apply to GTU from abroad are required to certify that they have the financial capacity to continue their higher education in Turkey in the form a financial assurance declaration. The amount and way of certification are determined by the Senate and is 3.000dollar for 2021-2022 academic year.

Education and Teaching

Foreign national students are subject to the provisions of the Regulations Governing Undergraduate Education and Teaching at GTU regarding the matters related to education and teaching.

In order to begin their undergraduate education at GTU, international students are to first certify that their Turkish language level is sufficient. The Turkish language proficiency of the admitted students is determined according to the certificate of success received from the YÖK-recognized Turkish language education providing centers (TÖMER) or from Yunus Emre Institutes.

Turkish Language Levels

1. Level (A) and (B) are insufficient.

2. Level (C1) and higher are sufficient.

Students whose Turkish level is insufficient are deemed permitted for 1 year to learn Turkish. Of the students whose Turkish reaches the desired level at the end of this period, those whose program's medium of instruction is Turkish may directly start their undergraduate education. (Economics and Geomatics Engineering)

Those students that study in a program with 30% English-medium instruction may continue their education from the course period provided that they pass the GTU English Language Proficiency Exam, or certify that they have passed an equivalent English language proficiency exam.

Those students who fail the GTU English Language Proficiency Exam, or fail to certify that they have passed an equivalent English language proficiency exam study in the English Language Preparatory Program. At the end of the 1 permitted year that has been granted for sufficient level of English to the foreign national students whose level of English is insufficient and are studying by their own means, those whose level of English is still insufficient are permitted for 1 additional year, and at the end of that additional year, if their level of English is still insufficient, they are disenrolled.

Students that have to prove their proficiency in Turkish and English languages have a total of two years to do so.
